Further, eligibility for MDA grant is subject to exporting companies having FOB value of exports up to Rs. 30 crores in the preceding year, having complete 12 months membership with EEPC India with regular filing of returns and fulfilling other conditions, details of which can be obtained from respective Regional Offices of EEPC India.
