As required by the provision of the Companies Act, 2013 their appointment has to be ratified by members each year at the AGM.

The observations of the Statutory Auditors, when read together with the relevant notes to the accounts and accounting policies are self explanatory. There are no qualification, reservation or adverse remark or disclaimer made by the said auditors in their report.

Number of meetings of the Working Committee

EXPORT PERFORMANCE

The Working Committee of EEPC INDIA has the pleasure in presenting its report on the activities of EEPC India for the year ended 31st March, 2018.

A. OVERALL EXPORTS UP BY 5.56% DURING APRIL-MARCH 2018

Based on the provisional data published by DGCI&S Cumulative value of exports for the period April-March 2017-18 was US \$ 302.84 Billion (Rs 1952168.79 crore) as against US \$ 275.85 Billion (Rs 1849428.76 crore) registering a positive growth of 9.78 per cent in Dollar terms and 5.56 per cent in Rupee terms over the same period last year.

B. PERFORMANCE OF ENGINEERING SECTOR IN FY 2017-18

According to the provisional data available from DGCI&S up to March 2018, India's export of engineering goods have registered a growth of 16% in US \$ Mln during the financial year 2017-18 in comparison to the same period in the previous fiscal. The provisional data indicates that exports of engineering goods from India have reached US \$ 76204.42 Mln up to March 2018 in comparison to US \$ 65239.16Mln in the previous fiscal.

This is the highest Engineering Export figure since Independence.

In rupee terms India's export of engineering goods are valued at ₹ 453111.42 crores during April-March 2017-18 which is 3.58% higher than ₹ 437428.76 crores during April-March 2016-17.

The engineering sector appears to retain its share around 25.16% in overall export from the country, which is maximum in terms of sectoral contribution.







1. MSV Brno 2017, 9-13 October 2017, Brno, Czech Republic

India was honoured to be named the Partner Country for the second time at the 59th edition of the International Engineering Fair (MSV). Five years ago, in 2012, India had been the Partner Country, and EEPC India was the lead agency to set up the India Pavilion. This time round, too, Minister of State for Commerce and Industry Minister, Mr C R Chaudhary led a contingent of over 90 Indian Participants representing Industrial Machinery, Iron and Steel, Industrial Design and General Engineering. Delegations from Indian States of Jharkhand led by Mr Raghubar Das, Chief Minister of Jharkhand and from Karnataka led by Mr R V Deshpande, Minister of Medium and Large Industries, Government of Karnataka and National Institute of Design are worth mentioning.

International Engineering Fair (MSV) held at the Brno Exhibition Centre, in Brno, Czech Republic, is billed as the number one International Engineering Fair in Central and Eastern Europe. This year, the 59th edition of the five-day fair was held over 9-13 October 2017. MSV 2016 saw 1704 exhibitors from 34 nations and 84,210 visitors from 52 countries with 70 per cent of the visitors being decision-makers and buying influencers along with the presence of over 400 accredited journalists.

2. INDEE BANGLADESH 2017, 2-4 November 2017, Dhaka, Bangladesh

The 37th edition of EEPC India's largest multiproduct exhibition INDEE made a successful debut in Bangladesh, considering the enthusiastic response from participants, trade delegations and visitors. INDEE Bangladesh held over 2-4 November 2017 at the International Convention City, Bashundhara, in Dhaka, Bangladesh, was inaugurated by Mr Alhaz Amir Hossain Amu, Minister of Industries, Government of Bangladesh.

Among the dignitaries present were Mr Harsh Vardhan Shringla, Indian High Commissioner to Bangladesh, Mr B S Bhalla, Joint Secretary, Department of Commerce, Government of India, Sheikh Fazle Fahim, First Vice-President, FBCCI (Federation of Bangladesh Chambers of Commerce and Industry), Mr Taskeen Ahmed, President, IBCCI (India Bangladesh Chamber of Commerce and Industry), and Mr T S Bhasin, Chairman, Mr Arun Kumar Garodia, Regional Chairman (ER), Mr P R Venkatachalam, Chairman of the Committee on Trade with SAARC, and Mr Bhaskar Sarkar, Executive Director and Secretary, EEPC India.

The three-day even witnessed the participation of around 100 Indian companies and organisations and more than 2000 focus trade visitors, The mega-event was organised with the support of the Ministry of Commerce and Industry, and Ministry of Micro, Small and Medium Enterprises (MSME), Government of India, Indian High Commission in Bangladesh and Bangladesh High Commission in India, IBEF, and leading Associations in Bangladesh – FBCCI (The Federation of Bangladesh Chambers of Commerce and Industry), BEMMA (Bangladesh Electrical Merchandise Manufacturers Association), BEIOA (Bangladesh Engineering Industry Owners Association) and IBCCI (India-Bangladesh Chamber of Commerce and Industry), among others. The Government of West Bengal fronted the Indian state participation, showcasing the Department of MSME and Textiles.

Among major PSUs, CPRI (Central Power Research Institute), CEERI (Central Electronics Engineering Research Institute), Powergrid Corporation of India, Indian Oil Limited, RITES (Indian Railways), and SAIL were the key Indian participants.

In his Welcome Address at the inauguration, Mr T S Bhasin, Chairman, EEPC India, said, 'Till date EEPC India has organised 36 INDEEs over 40 years in 25 nations across six continents and Dhaka hosts the 37th INDEE in the 26th nation. More than 100 top Indian engineering companies will demonstrate the latest development in engineering before Bangladesh by displaying their products from different key segments including Automobile, Power, Industrial Machinery, Domestic Appliances, Agricultural and Food Processing Machinery, Telecom, IT and IT-related Services, Medical and Scientific Instruments at the show. ... This exhibition was designed with a view to enhancing bilateral trade, mutual investment, joint ventures and technology transfer.'

Delivering the Inaugural Address, Mr Alhaz Amir Hossain Amu, Minister of Industries, Government of Bangladesh, said, 'India can set up industries in economic zones of Bangladesh to import products there that can help reduce the trade gap between the two neighbours. Bilateral trade between Bangladesh and India reached \$7 billion in 2016-17, but Bangladesh's trade gap is \$6 billion. To reduce this gap, India can set up industries here and import products from them.' Mr Harsh Vardhan Shringla, Indian High Commissioner to Bangladesh, commented, 'Bangladesh gets priority in bilateral relations of India. Bangladesh has now become an attractive investment place because it has achieved a steady economic growth.' India shares a unique bond and a special relationship with Bangladesh rooted in a common cultural heritage, shared principles and values and forged by common aspirations and sacrifices of its peoples.

Bangladesh has emerged as India's biggest trade partner in South Asia with a 17 per cent rise in India-Bangladesh bilateral trade during 2011-12 to 2015-16. The \$10 billion targeted bilateral trade by 2018 and \$14 billion worth of prospective and incumbent Indian investments in Bangladesh manifest their mutual significance in their respective business maps, according to Mr B S Bhalla, Joint Secretary, Department of Commerce, Government of India. He added that bilateral engineering exports have registered 16.17 per cent growth, making Bangladesh the 9th highest recipient of India's engineering exports during 2017-18 valued at \$1251.06 million, moving from the 13th position in the previous year with Industrial Machinery, Automobiles and Auto Components, Non-ferrous Metals topping the export basket.

A major attraction of the Expo was the India-Bangladesh Networking Evening, jointly organised by EEPC India and the Indian High Commission in Bangladesh, on 3rd November 2017 at Hotel Le Meridian in Dhaka. It was attended by more than 250 invitees from the two countries. The inimitable performance of the Kolkata based Band, Fiddler's Green, mesmerised the audience, lending a special ambience to the evening.

Finally, it was time for the Best Pavilion awards that went to Tata Motors (represented by Nitol Niloy Group) Ltd, Fortuner Group, and NIPHA Exports Pvt Ltd, under the Large, Medium and Small categories respectively while Indian Oil won the award under the PSU category.

EEPC India carried out an extensive publicity drive by releasing advertisements in the leading newspapers in prior to the exhibition, branding the exhibition area and publishing pre and in-show material with prominent EEPC India branding.

The match-making of the Indian and Bangladeshi businessmen was quite effective, generating 2533 contacts, according to the feedback received from participating companies. More than 88 per cent of the participants who sent in their feedback rated the event as excellent, 115 enquiries were generated with an average 42 contacts per participant and over 90 per cent of the participants appreciated the role of EEPC India as the organiser and evinced interest in participating in the second INDEE in Bangladesh scheduled for 15-17 November, 2018.



Brief Report on RCEP Task Force Meeting during 7 - 9 February, 2018, Yogyakarta, Indonesia

The 21st RCEP negotiation round between ASEAN and its 6 partners (India, South Korea, Japan, New Zealand, Australia, and China) was held at Yogyakarta, Indonesia. This round discussed the trade of goods and services, investment, issues regarding legalities and institutions, as well as the Rules of Origin (ROO). In order to expedite negotiation of ROO, a Task Force was formed under SWGROO (Sub Working Group on Rules of Origin). The main objective of the Task Force was to independently discuss and decide Product Specific Rules (PSR) for Chapters 84-85 (Machinery and Electrical Equipment). The meeting of the Task Force was held during 7-9 February 2018 at Yogyakarta.

The RCEP was built upon the existing ASEAN+6 FTAs with the spirit to strengthen economic linkages and to enhance trade and investment related activities as well as to contribute to minimize development gap among the parties. The planned RCEP will represent 28.5 per cent of global trade and 31.6 per cent of Gross World Product (GWP). Mr. Saikat Dutta, Joint Director (Policy), EEPC India, participated in the Task Force meeting and PSR negotiation representing Government of India.

- Mailing of EEPC India Territorial Newsletters EEPC India preparing various Newsletters on territory wise such as Africa, Latin America, North America, Europe, ASEAN-5, CIS, South Asia, Middle East and West Asia on monthly basis and mailing to all members of the Council and also hosted on website.



- Bulk Mailing Campaigns: The Bulk Mailing Campaigns were carried out to all members for Government Circulars, Notifications, Public Notices, Invitation Mailer for INDEE, IESS, Partner country events and also for Council's various promotional activities.
- Video Conferencing: Implemented in the Council's offices in Kolkata, Mumbai, Chennai and New Delhi. POLICY MATTERS

A meeting was organized by the Ministry of Commerce & Industry, Government of India on April 13, 2017 in New Delhi on various aspects of export related matters. The meeting was chaired by Ms. Rita A. Teaotia, IAS, Commerce Secretary where EEPC India was present and discussed the following issues –

Caution listing of exporters by RBI for non-closure of export realization

An exporter gets caution listed, if realization of a shipping bill remains outstanding for more than two years. Banks were advised vide RBI Circular No. 74 dated May 26, 2016 that procedure for cautioning / de-cautioning of exporters has been automated under EDPMS. Once the exporter's name appears in the caution list, the bank is obliged to suspend all export/import related transaction of the said party except against advance payment, L/C or usance bill.

In many instances the bankers may not update the realization details against a shipment upon the exporter/importer furnishing the proof of exports/imports and shipping bill will be reflected as outstanding. In some cases realization may remain outstanding because of dispute with the foreign buyer. The exporter, for no fault of his, may get caution listed in such cases.

(Note: As an interim relief RBI has decided to grant temporary exemption to exporters whose IE codes are appearing in caution-list in EDPMS up to April 20, 2017.)

RBI should not insist upon the copies of the Shipping Bill (Exchange Control copy and Export Promotion copy)

Customs vide its Circular No. 55/2016-Customs dated 23rd November, 2016 has dispensed with the requirement of printing of shipping bills.

Since the Customs has waived the need for shipping bill, RBI may be requested to make commensurate changes both in the FEMA notification as well as the Master circular on Exports. Bill of Exchange, Invoice, Airways bill or Bill of lading may be considered as the valid, bona fide documents in support of evidence for exports.

Third party/ third country payments for exports

For an export consignment the remitter can be different from the buyer. The remitter can be a third party, even located in a third country. For an instance, most of the buyers in Africa, prefer to make payments from Middle East/Europe. In some cases the advance is remitted by the buyer from one country but the balance is send from other country.

RBI allows third party payments for export / import transactions. Guidelines to banks for handling such transactions were issued vide RBI Circular No. 100, dated 4.2.2014. As per this circular, the need for a tripartite agreement was waived off and AD banks were advised to satisfy themselves with the bona-fides of the transaction and export documents.



The issue being face by the exporter is that some banks like SBI still insisting on tripartite agreement. Also, Banks are insisting on name of remitter upfront on shipping bill which even exporter is not aware of at the time of shipment.

Banks refusing to handle documents where Iran is a transit point for exports

RBI vide Notification No. FEMA 14(R)/2016-RB dated May 02, 2016 lifted the suspension on Asian Clearing Union (ACU) mechanism for Receipt for export of eligible goods and services, in any freely convertible currency from Iran. But, banks are refusing to handle documents where Iran is a transit point for exports elsewhere to Russia / Central Asia.

This is severely hampering the movement of cargo from India on INSTC route. Indian exporters are losing business even to adjoining countries if using the Bandar Abbas port.

Non-handling of export documents by Indian Banks with regard to export to Sudan

Some of the Indian Banks like HDFC Bank are not handling export/ import documents pertaining to Sudan. HDFC Bank has quoted compliance with "The Office of Foreign Assets Control" (OFAC) regulations of US as a reason for this. RBI has not issued any instructions to Banks for not handling export documents pertaining to Sudan.

The exporters to Sudan are unable to received payment for exports made by them.

Important FTP provisions in the context of the implementation of the GST

- (a) The GST has been implemented with effect from 1st July 2017, the term "Central Excise Authority" used in the Foreign Trade Policy 2015-20 and the Foreign Trade Procedures 2015-20 would be read as "Jurisdictional Customs Authority".
- (b) The Duty Credit Scrips cannot be used for payment of IGST and GST compensation cess in imports, and CGST, SGST, IGST and GST compensation cess for domestic procurement.
- (c) Under the GST regime, no exemption from payment of Integrated GST and Compensation cess would be available for imports under the Advance Authorization.
- (d) Importers would need to pay IGST and take input tax credit as applicable under the GST rules.
- (e) However, imports under the Advance Authorization would continue to be exempted from payment of Basic Customs Duty, Additional Customs Duty specified under section 3(1), 3(3) and 3(5) of the Customs Tariff Act. Education Cess, Anti-dumping Duty, Safeguard and Transition Product Specific Safeguard Duty, wherever applicable.
 - Applicable GST would need to be paid while making local procurement, using an invalidation letter of Advance Authorization/DFIA. Recipient of goods can take Input Tax Credit (ITC) of the GST paid on such local procurement. This Input Tax Credit can be utilized as per GST rules.
- (f) Advance Release Order facility shall not be available for procurement of inputs under Advance Authorization Scheme except for inputs listed in Schedule 4 of Central Excise Act, 1944 read with The Taxation Laws (Amendment) Act 2017 No.18 of 2017 with effect from 1st July 2017. RAs are directed not to issue ARO except for Schedule – 4 items as stated above.
 - Importers would need to pay IGST and take input tax credit as applicable under GST rules. ARO facility shall not be available for sourcing of Capital Goods manufactured indigenously.



(g) EOUs are allowed duty free imports of goods for their authorized operations. In GST regime, the import of goods covered under GST would be exempted from the whole of the duty of customs specified under the First Schedule to the Customs Tariff Act, 1975 (BCD) enabled by Notification No.52/2003-Cus. But such goods would attract integrated tax and compensation cess leviable under sub-section (7) and (9) of the said Act. The taxes so paid on imports will be neutralized by ITC.

Customs Tariff Act, 1975 (BCD) and also from the additional duty leviable under sub-sections (1), (3) and (5) of Section (3) of the said Act (CVD &SAD) enabled by notification No.52/2003-Cus.

For the indigenous procurement of goods covered under GST, the EOU will not get ab-initio exemptions. Such supplies would be on payment of CGST/SGST/UTGST/IGST. The taxes so paid will be neutralized by ITC. For the indigenous procurement of goods covered under Fourth Schedule, the EOUs will continue to get ab-initio exemptions from central excise duty.

EOUs would be required to pay only CGST & SGST or IGST, as the case may be, besides paying back of whole of the duty of customs specified under the Firt Schedule to the Customs Tariff Act, 1975 (BCD) exemptions, if availed, on inputs used in manufacture of such finished goods.

The DTA clearances of finished goods covered under Fourth Schedule of the Central Excise Act, 1944, the EOUs would be required to pay central excise duty equal to the aggregate of duties of customs in view of proviso to section 3(1) of the Central Excise Act, the effective rate of such duties being covered by Notification No. 23/2003-CE.

Inter unit transfer/supply for EOU to other EOUs. Applicable GST would be payable on the transfer/supply of goods from one unit of EOU/EHTP/STP/BTP to another.

Problem in exports to SAARC countries

Bangladesh

(a) Free of Supplies during warranty period

Indian capital goods manufacturers and exporters normally give 24 months warranty period to our customers. During this period, if any item is found defective/damaged, manufacturers need to replace those items on Free of Cost (FOC) basis. However, Indian manufacturers are facing problems in sending FOC materials to Bangladesh. There is no clear cut guidelines on sending Free of Cost shipments to Bangladesh. Feedback from Bangladesh manufacturers is that if the value is minimal the goods can be cleared from Bangladesh Customs. We understand that no Bangladesh customs circular or guidelines or any other guidelines available. Hence, a request may be made to the Bangladesh officials to issue guidelines on supplying goods on Free of Cost basis.

b) Road Shipment to Bangladesh

Indian companies experience huge delays in clearing the cargo both at Petrapole and Benapole borders. Currently, trucks/trailers get detained at the border for minimum 20 - 25 days, resulting into huge detention charges as well as many times, the L/C gets expired.

(c) Restructuring of Duties by Bangladesh under Chapter 72

Bangladesh Government through their Budget in June 2016 and June 2017 restructured the duty structure in many products under chapter 72. The sole aim of such movement is to deny the SAFTA Benefit to countries signatory to SAFTA Agreement including India. They have brought down custom duty to NIL and replaced the same by putting Regulatory Duty of the same rate. Regulatory duty is imposed to protect the local industry from cheap import and is



over and above the Custom duty. For instance, on Ingots and billet duty was Taka 700 only per mt against SAFTA but now it has been revised to CD 0, RD 20% and Vat 15%.

(d) Customs Duty reduction is just to deny SAFTA benefit to India

Interestingly, some products are not manufactures in Bangladesh or have just one manufacturer capable of meeting not even 50% of their local requirement. Some of the products where such changes have been made are as follows:

(e) Issues related to Banking

As per the International Banking rules LC Opening Bank is required to make the payment of documents within 5 working days. In many cases the Banks in Bangladesh withhold the payment either by raising some discrepancy or even without that also. In case of UPAS LC (LC is on 90/180 days sight but the exporter is paid on sight) the document acceptance is not given for 30/45/60 days. In many cases without making the payment or conveying the acceptance, they issue the DO (Delivery Order) on customs to the importer to take delivery of the cargo. The Importer gets delivery of the cargo from customs and raises the disputes threatening to block the payment by moving to court etc.

Often the L/Cs are not concise in terms of description. Also L/Cs call for too many documents. It is suggested that the description should be very concise.

In sum, such Banking modus operandi and dealing issues need to be discussed and UCP guidelines need to be strictly adhered to.

Nepal

(a) Exports to Nepal: New Circular issued by Nepal Rashtra Bank

According to this circular, EXPORTERS FROM INDIA ARE REQUIRED TO SUBMIT THE EXPORT INVOICE UNDER GST WITH ZERO RATE TAX QUOTING THE LUT / BOND NO. Otherwise the payment will be made in Indian Rupee and Not Foreign Currency.

It is silent on Export Invoice charging 18% IGST.

As per GST Rule exporter have both the option of raising the export invoice with ZERO tax under LUT/Bond or charging 18% IGST. Here Nepal is restricting the movement under LUT or Bond only to get the payment in Foreign Currency. This is a kind of Non-Tariff Barrier and either IGST payment should be also included to be shown or the requirement be done away with.

GST Related Issues

(a) Transitional Period

There are considerable issues with members unable to file their details, especially with regard to Tran-1. If this is not made smoother, exporters are unable to get the carry forwards and view their input tax credit. This issue needs to be addressed at the earliest.

The critical stage is the transitional period, viz., from July 1, 2017 to September 30, 2017, wherein there is likely to be severe blockage of funds due to the fact the filing date of outward supply is on September 5, 2017 for all the supplies carried out in the month of July 2017. This means the refunds on exports will be available either at the end of September or first week of October. Our members have informed that it would be impossible for them to export in August and September as per this refund time schedule. We request that kindly urge the Commerce Secretary to make the GSTN operative for processing returns and refunds by the beginning of August, so that the Customs via ICEGATE can start processing the refund applications and give the refunds by end August for supplies and exports in July 2017.

(b) IGST on Advance Authorization

We would also like to draw kind attention of imposing IGST of 18% on raw materials, import even under advance authorization licence for export orders. This will affect heavily on cash flow of Exporters to sustain in international competitive market. AA should be exempted from IGST.



(c) MEIS Scrips Utilization

Pre GST, MEIS license (Scrip) was allowed to utilize for payment of Excise, Service Tax, VAT etc. as per policy, whereas post GST implementation MEIS License can be utilized only for Basic Customs Duty payment, which is unfair and withdrawal of benefits to Exporters. Hence, this also has added additional cash outgo burden to Exporter for import clearance for export orders. This is going to affect very badly on Exporters cash flow and working capital. With respect to MEIS, the duty credit scrips should be allowed to neutralize CGST + SGST/IGST in line with what was the situation in the pre-GST period.

Council seeks a clarification on the HSN of Duty Credit Scrips under Chapter 3 of the Foreign Trade Policy. If it is HSN 4907 which has a GST rate of 12%, we feel this should be lowered to 0% or at least to 5% which was the VAT rate.

RBI Related Issues

(a) RBI Caution Listing

There is the continuing problem of RBI caution listing. RBI has extended the deadline till August 31, 2017, but the problem with regard to payments received from OFAC list of countries like Sudan, Syria, etc and Foreign Currency Payments received from Iran remain a problematic area. Further, many banks are short staffed and that is affecting sorting out such problems. A policy on payment from OFAC countries should be formalized by the DOC.

(b) Rupee Appreciation

EEPC India has been expressing its concern for some time now and Council has also written to the RBI the continuous one way movement of the Rupee at a time when the Chinese Yuan is depreciating. Accordingly, it is our submission that since one of the critical objectives of the RBI is to moderate the excess volatility as part of the exchange rate management, we feel that the nominal exchange rate should have some correlation with the REER and the REER could be the signal of exchange rate management to moderate excess volatility. In this respect, the RBI had sometime back expanded the 5-country indices with a new 6-country index (by including the Chinese Yuan in the index) and has also been publishing the same in detail in the monthly official publication of the Reserve Bank of India. We suggest that movement within 5% of the nominal rate to the REER be acceptable, while the movement between 5 to 10% could be within the watch of the RBI and the deviation more than 10% should warrant intervention by the RBI. This would give some stability in terms of policy being pursued by the RBI and also indicate to exporters and other stakeholders the path that rupee path can take and enable them to quote appropriate prices to their foreign buyers.

We had taken up the matter both with RBI Governor and the Commerce Secretary and we urge our Joint Secretary to also highlight at his level with concerned officials.

Increasing in Steel Prices

EEPC India has been receiving representation from the members expressing their concerns over the increasing steel prices that is impacting adversely their cost of engineering products. Prices of Pig Iron, Billets, HRC have been increasing in some of the leading engineering centers in India. This is making it difficult for engineering exporters to be competitive at a time when they are already having transactional problems with GST.

RCEP Negotiation

EEPC India participated in the 19th Round of RCEP negotiations on 25 July 2017 at Hyderabad. Following points were raised by EEPC:

- The Government should ensure a differential tariff schedule in RCEP especially for China.
- To ensure seamless movement of products and services, RCEP should include a quality schedule along with the tariff schedule:



- To overcome standards related problems, the members can explore the possibility of signing of Mutual Recognition Agreements (MRAs) which allows equivalence of standards;
- Transaction cost is a huge concern of the exporting community. Ensuring Ease of Doing Business and reduction of transaction cost should be a priority of the RCEP members.

US GSP Review

The US Government has withdrawn unilateral tariff preference under GSP granted by the US to Indian origin exports for 48 tariff lines. Out of the 48 tariff lines, following 8 tariff lines of engineering products with their relevant US MFN duties have been abolished.

Further, USTR office has announced initiation of its annual GSP product and country practices review. During this review, importers, foreign governments, and other stakeholders have the opportunity to petition the US government for changes in the coverage of the GSP. Petitions may be sent to add or remove products from the list of imports that are eligible for GSP benefits. The USTR will also consider petitions to review the GSP eligibility of any country currently benefiting from the programme. The deadline to submit petitions through comments is 12th September, 2017.

We have requested our members to file suitable petition as per the US GSP Federal Register Notice that we have already circulated to them on August 21, 2017. EEPC India wishes to also file petition on tariff lines based on exports data and member's inputs. Accordingly member-exporters have also been requested to provide their relevant inputs to the Council for taking it up with the Indian Government as well as the US Government.

Announcement of Mid-Term review of FTP 2015-20

The Hon'ble Commerce and Industry Minister, Mr. Suresh Prabhu released the Mid-term Review of the Foreign Trade Policy (FTP) 2015-2020 on 5th December 2017 in New Delhi in the presence of Hon'ble Minister of State for Commerce and Industry, Mr. C R Chaudhary, Finance Secretary, Mr. Hasmukh Adhia, Commerce Secretary, Ms. Rita Teaotia, Secretary, Department of Industrial Policy & Promotion, Mr. Ramesh Abhishek and the Director General of Foreign Trade, Mr. Alok Chaturvedi.

The FTP will focus on exports from labour intensive and MSME sectors by way of increased incentives in order to increase employment opportunities. Emphasis will be given on 'Ease of Trading' across borders. Information based policy interventions will be ensured through a State-of-the-Art Trade Analytics Division. While share in traditional products and markets will be maintained, the focus will be on new products and new markets. The Commerce Minister focused on transparency and trust with the industry and maintenance of Quality Standards to succeed in the international market. We furnish below the highlights of the Mid Term Review of FTP:



Highlights of Mid Term Review of FTP

While restoring the benefits under the export promotion schemes of duty free imports under Advanced Authorization, Export Promotion Capital Goods and 100 percent Export Oriented Units and thus resolving the problem of blocked working capital for exporters following the roll out of GST, the FTP review has focused on increasing the incentives for labour intensive MSME sectors. Export incentives under Merchandise Exports from India (MEIS) have been increased by 2 per cent across the board for labour intensive MSME sectors leading to additional annual incentive of Rs. 4,567 crore. This is in addition to the already announced increase in MEIS incentives from 2 per cent to 4 percent for Ready-made Garments and Made Ups in the labour intensive Textiles Sector with an additional annual incentive of Rs. 2,743 crore Further, incentives under Services Exports from India Scheme (SEIS) have also been increased by 2% per cent leading to additional annual incentive of Rs. 1,140 crore.

Thus, incentives under the two schemes have been increased by 33.8 per cent (Rs. 8,450 crores) from the existing incentives of Rs. 25,000 crore leading to boost in exports from the labour intensive sectors and increased employment opportunities. Some of the major sectors benefited are as under:

- Rs. 2,743 crore for Readymade Garments and Made ups in Textiles Sector;
- Rs 749 crore for Leather and Footwear Articles;
- Rs 921 crore for handmade Carpets of Silk, Handloom and Coir and Jute products;
- Rs 1,354 crore for Agriculture and related products;
- Rs 1,140 crore for Services including Hotel & Restaurant, Hospital, Educational Services etc.
- Rs 759 crore for Marine products:
- Rs 369 crore for Telecom and Electronics Components;
- Rs 193 crore for Medical and Surgical Equipment.

Further, the validity period of Duty Credit Scrips has been increased from 18 to 24 months and GST rates on transfer/sale of scrips has been reduced to zero. Issue of Gold availability for exporters has been resolved by allowing Specified Nominated Agencies to import Gold without payment of IGST. Support to Export Credit Guarantee Corporation is also being enhanced to increase insurance cover to exporters particularly MSME's exploring new or difficult markets.

A new scheme of Self-Assessment based duty free procurement of inputs required for exports has been introduced. There will be no need of Standard Input Output Norms in such cases and this will eliminate delays. It is based on trust. Exporters will self-certify the requirement of duty free raw materials/inputs. The scheme would initially be available to the Authorized Economic Operators (AEOs) and will get expanded as more exporters join the AEO programme. The scheme will improve ease of doing business.

Contact@DGFT service has been launched on the DGFT website (www.dgft.gov.in) as a single window contact point for exporters and importers for resolving all foreign trade related issues and also to give suggestions. Exporters/Importers can track status of their queries through the assigned reference number. Feedback mechanism has also been provided. High level monitoring of disposal is being ensured.

A State-of-the-Art Trade Analytics division has been set up in DGFT for data based policy actions. The initiative envisages processing trade information from DGCIS and other national and international databases related to India's key export markets and identify specific policy interventions.



A new Logistics Division has been created in the Department of Commerce to develop and coordinate integrated development of the logistics sector, by way of policy changes, improvement in existing procedures, identification of bottlenecks and gaps, and introduction of technology based interventions in this sector. These steps would improve India's ranking in the Logistics Performance Index (LPI) and promote exports and enhanced growth.

Focus will be given to Ease of Trading across borders. A professional team to handhold, assist and support exporters in their export related problems, accessing export market and meeting regulatory requirements. The team will also examine the procedures and processes in clearances related to trading across borders for their simplification and rationalization and track progress. Dwell time at ICDs, ports and airports is being closely monitored in coordination with Customs, and Infrastructure Ministries.

The Foreign Trade Policy will continue to be reviewed and evaluated regularly for addressing concerns of the exporters, simplification of procedures and for promotion of exports.

Parliamentary Standing Committee on Commerce Meeting

The Parliamentary Standing Committee on Commerce organized a meeting on 10th November, 2017 in New Delhi on the Impact of Goods and Services Tax (GST) on Exports. EEPC India submitted its detailed comments. Mr. Pankaj Chadha, Vice Chairman, Mr. Pradeep Kumar Aggarwal, Member of the Working Committee and Mr. Suranjan Gupta, Addl. Executive Director, represented EEPC India at this meeting.

New Duty Drawback Rates for 2017-2018

The Ministry of Finance, Department of Revenue has notified All Industry Rates (AIR) of Duty Drawback vide Notification No. 89/2017-Customs (N.T.) dated 21.09.2017. This Notification comes into force on 01.10.2017.

Record of Discussion between EEPC and Government on Export Refunds held on November 23, 2017 in New Delhi

EEPC Chairman, Mr. T S Bhasin and Vice Chairman, Mr. Pankaj Chadha along with the Secretariat met the Finance Ministry Officials on November 23, 2017 to discuss the problem of refunds faced by its members. Here, a gist of the discussion and the remedies suggested by senior officials are being provided for information of members. Members are requested to kindly note the deliberation to solve the refund problem. It may be mentioned that the discussion highlights some future action by Government and hence the error corrections will be possible when the same is carried out by the Government. This is likely to be done by next week.

The Finance Ministry Officials reiterated that the Government is committed to refunding zero rated goods and will do everything in this direction. The Government is keen to ensure that there is minimal human interface and it is for this reason technical glitches that are arising are being corrected and leading to delay.

IGST Paid refunds

- (a) Please see your GSTR 1, GSTR 3B and Shipping Bill filed by you for every month. Please match all the details (field to field) and ensure all are the same. For example, even non-mandatory codes like Port Code in GSTR 1 are filed.
- (b) The Government is likely soon amend Table 9A in CBEC Board Circular No. 42/2017 dated 7/11/2017 to Table 9 for August onwards, so that errors made can be corrected in August 2017 returns.
- (c) Further, the Government is likely to include a field in ICEGATE where exporters will be able to find out the errors in their respective shipping bills so that they can take corrective steps as mentioned in Point b).



Some specific errors raised by EEPC India Team and the solution proposed in the discussions are given in the Table below :

Other errors

- A. Some ports have also issued documents show casing errors in the mis-match of data for month of July 2017 There are lists stating "Refund Not Granted". EEPC India submitted a copy of the same and the Government will look at the problems in such lists and resolve the same.
- B. There are problems with exports from ports/ICD and the Government is aware of this and the problem of e-filing in such stations will be resolved in a day or two.
- C. EEPC India pointed out the issue related to bank account validation with PFMS. The advise was to get in touch with the local Drawback Officials at the Cutsoms and they will help in making corrections.
- D. EEPC India pointed out that lately Drawback payment has stopped in some cities. The Officials mentioned that they were aware of this issue and is being resolved.
- E. LUT/Bond Refund
 - For this relevant Circular No.17/17/2017-GST dated 15th November has been issued for manual filing and processing.
- F. Electronic Sealing: Finance Ministry Officials requested EEPC India help to highlight the benefits of Electronic Sealing to its members. They mentioned that a study was carried out by the Government and the cost will get lowered for exporters if they use Electronic Sealing facility. EEPC India pointed out the inadequacy of seals and it was mentioned that it was for this reason, the system has been made voluntary till December 15, 2017.

Union Budget for the year 2018-2019

The Hon'ble Union Finance Minister, Shri Arun Jaitley has presented the Union Budget for the year 2018-2019 on 1st February 2018. The key takeaways of the Budget 2018 are reforms to rural India and farmers, healthcare and education, boost to "Make in India" campaign, etc. The Budget has introduced a flagship National Health Protection Scheme by Government to bring the poor families for hospitalization facilities. The Finance Minister has shown commitment to infrastructure sector by focusing on timely completion of existing projects. While focusing on sectors like agricultural, healthcare, the budget has reduced the corporate tax rate for small companies, cess on health and education increased by 1%. The Union budget 2018 can be seen as a stepping stone to paved the way towards economic growth and sustainability, job creation, by concentrating on crucial sectors of agriculture, infrastructure and health care.

The Hon'ble Finance Minister in his budget speech proposed to change the name present of the Central Board of Excise and Customs to Central Board of Indirect Taxes & Customs.

The CBEC has issued a Notification No.6/2018 Customs dated 2nd February 2018 notifying the increasing of the Basic Customs Duty(BCD) on certain items consequent to Budget changes proposed in the Union Budget 2018-2019. These increases would be effective from 00.00 hours on 02.02.2018.

The RBI has issued a Notification No. RBI2017-18/129 dated 07.02.2018 regarding relief for MSME Borrowers registered under Goods and Services Tax (GST)

Presently, Banks and NBFCs in India generally classify a loan account as Non-Performing Asset (NPA) based on 90 days and 120 days delinquency norms, respectively. It has been represented to us that formalization of business through registration under GST had adversely impacted the cash flows of the smaller entities during the transition phase with consequent difficulties in meeting their repayment obligations to Banks and NBFCs. As a measure of support to these entities in their transition to a formalized business environment, it has been decided that the exposure of Banks and NBFCs to a borrower classified as micro, small and medium enterprise under the Micro, Small and Medium Enterprises Development (MSMED) Act, 2006, shall continue to be classified as a standard asset in the books of Banks and NBFCs subject to the following conditions:

- i. The borrower is registered under the GST regime as on January 31, 2018.
- ii. The aggregate exposure, including non-fund based facilities, of Banks and NBFCs, to the borrower does not exceed 250 million as on January 31, 2018.
- iii. The borrower's account was standard as on August 31, 2017.
- iv. The amount from the borrower overdue as on September 1, 2017 and payments from the borrower due between September 1, 2017 and January 31, 2018 are paid not later than 180 days from their respective original due dates.
- v. A provision of 5% shall be made by the Banks/NBFCs against the exposures not classified as NPA in terms of this circular. The provision in respect of the account may be reversed as and when no amount is overdue beyond the 90/1201 day norm, as the case may be.
- vi. The additional time is being provided for the purpose of asset classification only and not for income recognition, i.e., if the interest from the borrower is overdue for more than 90/120 days, the same shall not be recognized on accrual basis.



E-Sealing is mandatory from 1st March 2018 for all categories of exporters

The Office of the Commissioner of Customs (Port), Custom House, Kolkata has issued a Public Notice No. 14/18 intimating that the E-sealing is mandatory from 1st March 2018 for all categories of exporters except those who are found ineligible for self-sealing facility.

DGFT has issued a Trade Notice No. 23/2015-2020 dated 6th February 2018 on advice to exporters to promptly check Shipping Bill transmission status on ICEGATE and DGFT websites

It has come to notice of this Directorate that when exporters login into DGFT system for MEIS application, sometimes Shipping Bill data is not found available in DGFT System. It takes considerable time to get the SB data available in DGFT system and, therefore, availing of FTP benefits, like MEIS, by exporter is delayed.

The Shipping Bill data is transmitted from Customs Port Offices to ICEGATE server and subsequently to DGFT server. To overcome this issue, it is advised to exporters to check the Shipping Bill transmission status first on ICEGATE and then on DGFT website after 72 hours from integration of SB with ICEGATE. If the SB data is not available on ICEGATE or DGFT, the issue should be reported to the concerned authorities. The issue can be registered with DGFT in the Contact@DGFT service available on DGFT website and the issue details can be shared with DGFT EDI helpdesk by sending to an e-mail at dgftedi@nic.in quoting the contact @DGFT reference number.

The DGFT has issued a Public Notice No.62/2015-2020 dated 16th February 2018 on Directives for processing of application for MEIS under Foreign Trade Policy 2015-20

- 1. In pursuance of the objective of improving ease of doing business, implying the procedures, cutting down delays and to increase the transparency in processing the applications for MEIS claims, the Director General of Foreign Trade, in exercise of the powers conferred under paragraph 1.03 of the Foreign Trade Policy 2015-20 issues the following directives to all the Regional Authorities with immediate effect.
- 2. Except for the ITC (HS) Code specified in Annexure to this Public Notice for all other notified ITC(HS) Codes in Table 2 of Appendix 3B of HB, Regional Authority shall process applications for MEIS Claims only on the basis of ITC (HS) Codes as specified in the Shipping Bill. In respect of the ITC Code specified in Annexure to this Public Notice, Regional Authority (RA) shall continue to process the applications for MEIS claim after matching the description as well in the Shipping Bill with Export Product Description in Table 2 of Appendix 3B. The list of ITC (HS) Codes in the Annexure to this Public Notice is likely to change from time to time.
- 3. The Directives in this Public Notice shall be followed for all applications which have not been finalized (finalized would mean that either the Scrip has been granted or applications in which DGFT HQs or the RAs have already rejected a claim) as on date of issue of this Public Notice. Thus, past cases which have been decided will not be reassessed based on the Directives in this Public Notice.

Effect of Public Notice: Directives are issued to all Regional Authorities for processing the application for MEIS claim with the objective of improving ease of doing business, simplifying the procedures, increasing transparency and to cutting down delays.

The DGFT has issued a Trade Notice No. 24/2015-2020 dated 21st February, 2018 on Information on details of Shipping Bills in cases where exporters who have inadvertently ticked "N' (for No) instead of "Y" (for Yes) in "Reward" column of Shipping Bills while filing the EDI Shipping Bills, but have declared the intent in the affirmative (in wordings) in the Shipping Bill

1. Representations have been received in this Directorate seeking extension of benefit of Merchandise Exports from India Scheme (MEIS) to such cases/Shipping Bills where exporters have inadvertently ticked "N" (for No) instead of



"Y" (for Yes) in the "Reward" column of Shipping Bills while filing the EDI Shipping Bills, but have declared the intent in the affirmative (in wordings) on the shipping bills. In order to gauge the problem and the financial implications, following information is being asked for considering the matter.

2. It is requested that the exporters who have Shipping Bills which got ticked "N' (for No) instead of "Y' (for Yes) in "Reward" column of Shipping Bills while filing the EDI shipping bills, but have declared the intent in the affirmative (in wordings) on the Shipping Bills may send the details in excel format as in the table below by 31.03.2018 at the mail address: lokesh.hd@nic.in. While sending the details it may please be noted that the shipping bills which had a Let Export date from 01.10.2015 to 31.03.2016 only should be included. Also, Shipping Bills in which declaration of intent has been allowed by Customs authorities later, by manual amendment or otherwise should be excluded from the table below:

NOTES ANNEXED TO AND FORMING PART OF THE BALANCE SHEET AS AT 31ST MARCH, 2018 AND STATEMENT OF INCOME & EXPENDITURE FOR THE YEAR ENDED ON THAT DATE.

NOTE-1: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- 1.1. Expenses/Income, especially those relating to specific projects, are accounted for in the year for which budget approval has been granted and not necessarily in the year of incurrence of expenditure. Any payment/receipt on that account is kept under advances/liabilities till the year of budget approval.
- 1.2. Expenditure related to various Code and other specific activities are booked under those functional heads to conform to the budgets approved by the Government of India. As such, expenses shown under various natural heads are not necessarily the total expenditure incurred under these particular heads.
- 1.3. The subscription income from members is not taken into account unless received except in cases where the GST invoice was raised for such subscription.
- 1.4. Items of printing and stationery are charged to Statement of Income & Expenditure of the year in which the same are purchased.
- 1.5. Pursuant to the policy adopted by the management in 1982-83, the expenditure on Publication is directly charged to Income & Expenditure account and no stock of publications at the end of the year is accounted for, as these are considered purely export promotional literature.
- 1.6. Interest accrued on House Building, Vehicle and Computer Advances are accounted for by way of directly crediting the same to "Staff Welfare Fund" account instead of routing them through Statement of Income & Expenditure.
- 1.7. The Building Fund has been directly credited with Rs.1.5 crore out of the total collection of Membership Subscription during the year to facilitate purchase of properties for the use of the Council. Further, the interest received/accrued amounting to Rs.1,09,41,906/- on the earmarked fixed deposits of Building Fund with banks has also been directly credited to the Building Fund A/c.
- 1.8. Provision for Gratuity & Leave Encashment is based on actuarial valuation on the present value of future liability which includes Rs.65,16,004/- being interest on earmarked investments of Gratuity & Leave Encashment fund directly credited to the Provision for Gratuity & Leave Encashment Account.
- 1.9. Till 31.03.2014, the depreciation was being provided under the W.D.V. method at the rates prescribed under schedule XIV of the Companies Act, 1956. From the financial year 2014-15. The depreciation is being provided on the basis of the useful lives of the fixed assets prescribed under Schedule II of the Companies Act, 2013.
- 1.10. Foreign Currency Transaction:

Transactions through the foreign currency bank accounts maintained by the Council have been transacted at the standard fixed rates adopted for the year and not at the actual rate prevailing on the date of transaction. The other transactions in foreign currency have been accounted for at the actual rates prevailing on the date of transaction.



NOTE-3: OTHER EXPLANATORY INFORMATION

- 3.1. Every member of the Council other than the Officials of Government undertakes to contribute to the assets of the Council in the event of the same being wound up during the time that he was a member or within one year afterwards, for payment of the debts and liabilities of the Council contracted prior to the date on which he ceases to be a member and the costs, charges and expenses of winding up the same and the adjustment of the right of the contributories among themselves, such amount as may be required not exceeding Rs.1,000/-in the case of Ordinary Members and Rs.50/- in the case of Associate Members.
- 3.2. Secured Loans to employees for house building and purchase of vehicles include cases where mortgage/ lien could not be created on the year end.
- 3.3. The Council is separately maintaining bank accounts (including deposit accounts) in connection with EEPC Pension Fund, International Price Reimbursement Scheme etc. as a custodian only, which are not forming part of the Council's accounts.
- 3.4. a) The Council is maintaining a Joint Bank Account for making joint payments on behalf of itself and other occupants in relation to the office space acquired in the International Trade Facilitation Centre at Kolkata. As the Council is only acting as a custodian of this bank account, the same does not form part of its accounts.
 - b) The said bank account was opened for the convenience of these occupants in making those payments which are common in nature, such as, premises maintenance expenses, security services, electricity, water supply, lift maintenance etc. The funds required for such expenses are contributed by all these occupants on a mutually agreed basis.
- 3.5. No provision for Income Tax has been made in the accounts as the Council does not expect any liability on this account.
- 3.6. Contribution from participating members as shown in Note 2.12 includes amounts towards exhibitions, publicity, conferences etc.
- 3.7. In the absence of confirmation from the parties, various accounts like Loans & Advances, Deposits, Sundry Creditors etc. remain unconfirmed.
- 3.8 Previous year's figures have been regrouped/rearranged and nomenclature changed to make them comparable, as far as practicable, with those of current year.
