For this, the candidate has to submit individual unit wise investment in Plant and Machinery (Gross Block) for the year 2017-18. No certificate regarding MSME/SSI/or Certificate from Directorate of Industries will be considered as valid without above balance sheet and in that case the Award Application will be considered as incomplete and liable to be rejected.
- 5. The applicants are also required to submit a copy of the Certificate issued under the MSME Act 2006 certifying the applicant as Micro, Small or Medium Enterprise.
- 6. A declaration in the letterhead of the Organization stating that the company is not in the 'Denied Entity List' at the time of submission of the award application.
- 7. A No-Objection Certificate in case of Indirect Exports.

N.B

- ➤ In the event, of any Award offered to any Exporter is found to be in appropriate, Award Committee will decide for corrective action. In the reverse case that is if the Award Application is found to be incorrect after the award is offered, Award Committee may request for withdrawal and return the same Award to its Regional or Head Office as per their convenience.
- The Award Applications would be collected from the Head Office for selection of Award Winners at the Regional Level for the same year as considered for All India Level.

Members are requested to carefully go through the Award Scheme and furnish applications complete in all respect.
